

Health and Care (Staffing) (Scotland) Act 2019

12IR 'HIS: Monitoring and Development of Staffing Tools'

Updates to staffing level tools to reflect the 36 hour reduced working week

1.0 Introduction

Healthcare Improvement Scotland (HIS) recommends to Scottish Ministers revisions to the staffing tools, prescribed under section 12IJ (3) of the Health and Care (Staffing) (Scotland) Act 2019 (HCSA) as follows:

The revision of the 'Adult Inpatient Staffing Level Tool Version 4' with a new revised staffing level tool 'Adult Inpatient Staffing Level Tool Version 5'

- Type of healthcare: Adult inpatient provision
- Location: Hospital wards with 17 occupied beds or more on average
- **Employees:** Registered nurses (including other staff working under the supervision or delegation by the registered nurse)

The revision of the 'Small Wards Staffing Level Tool Version 3' with a new revised staffing level tool 'Small Wards Staffing Level Tool Version 4'

- Staffing tool: Small Wards Staffing Level Tool Version 4
- Type of healthcare: Small ward provision
- Location: Hospital wards with 16 occupied beds or fewer on average
- Employees: Registered nurses (including other staff working under the supervision



or delegation by the registered nurse)

2.0 Revision to the tools: reduced working week

HIS proposes a revision to all the staffing level tools and professional judgement tool prescribed under section 12IJ (3) based on the reduction in the working week for Agenda for Change staff as follows:

- 2.1 The 2023/24 pay settlement for healthcare staff governed by Agenda for Change (AfC) agreed to explore the feasibility of a reduction in working hours. This is with the overall aim of reducing to a 36-hour working week.
- 2.2 From the 1 April 2026 fulltime staff in NHS Scotland employed on Agenda for Change terms and conditions will be 36 hours per week, not 37 hours. Staff on part-time hours will benefit from a pro rata reduction proportionate to full-time colleagues.
- 2.3 This had implications for the output of the staffing tools prescribed under section 12IR of the HCSA. The staffing tools are currently based on the standard working week of 37 hours.

- 2.4 HIS have undertaken a review of all the staffing tools and worked closely with the technical provider Atos to identify all the necessary changes to the staffing tools hosted on the Scottish Standard Time System (SSTS) platform.
- 2.5 HIS will commission Atos to start work on the necessary revisions to the tools. This work will be undertaken between September 2025 to February 2026 in preparation for when the updated regulations are laid before parliament.
- 2.6 HIS will update the Business Objects XI (BOXI) reports for all the staffing tools to include the calculations to reflect the reduction from 37 to 36 hours. This will support board's workforce planning in preparation for future reductions to the standard working hours.

3.0 Recommendations

3.1 HIS recommend the following amendments to The National Health Service (Common Staffing Method) (Scotland) Regulations 2025, that accompany the Health and Care (Staffing) (Scotland) Act 2019, as follows:
